

Fred would like to have policy 202 reviewed by attorney to ensure we do not conflict with special district rules. Chief would like to hold as there may be additional policies for attorney review.

- Grants
  - No response yet from FEMA
  - CO EMTS submitted for 2018, includes technical rescue, swiftwater rescue and ambulance equipment mounts to appropriately secure equipment @ 50% match
    - Awaiting second part of defense in May time and date to be announced
  - Submitted mineral lease grant edited slightly from previous submission, but for same equipment – cell phone, stations booster, vehicle boosters @ 0% match

     this will hopefully illuminate some of the more obscure grant opportunities for us
