Fire Chief's Report

November pretty slow month with 5 incidents. Year to date 92 calls Began integrating training materials; next step integrate personnel to a mix of paid and volunteer

Chairman's Report

Met with the Norwood folks regarding mill levy, which did get passed. Fred asked to meet in January to discuss materials she is gathering for their mill levy. In speaking with her and Department attorney, off-cycle is not the time to pursue levy. Rather should do during general election year, saving time and money. Norwood was able to pass both mill levy and deBruce. GUFD would like to pursue both; without deBrucing money will not increase with need.

New truck transport is going well thanks to David Dormaier. The two vehicles being sold did not have title. Gentleman in Kentucky we've purchased new truck from is okay with holding on to new truck title until he receives our titles. This new vehicle will replace the function of 3 vehicles.

In getting the titles for vehicles being sold, State trooper handling the title shared excitement of having access to GUFD building and having office here.

Chief Barnett and Fred attended central com meeting to find out who is responsible to pay power for radio site. Discovered that GUFD was never supposed to pay. Not sure it's possible to recoup the \$3,500/year over last 8 years, but will request. If not, Madonna also suggested perhaps some kind of trade in equipment etc.

Gift cards for staff: In year's past fire department purchased \$500 in dinner gift cards in \$25 increments as thank you to staff. Questioned, and confirmed, department did have funds to do again this year.

Line Medic Course

Training in Colorado Springs January 9th; benefits department in improvement in staff skill plus possible revenue in participating in federal incident. Department would get paid for apparatus, not personnel.

Board supports training but cannot afford training course at this time.

Request for gift certificate

Chief Barnett requested gift certificate for David Dormaier's father in law for his assistance in transporting new truck. Board decided on \$50 gift card to Texas Roadhouse.

Power bill for department's share of Community Building

Chief Barnett requested power bill be sent directly to fire department instead of passing through Community Building personnel. Board agreed.

PIF/PUD funding

John asked for update on funding; Fred said it looks possible to get \$40-50,000 from County. John Williams is pursuing with Mesa County.

Fred has asked Chief Barnett to join meeting with Tia Cudahy and Rudy Sharp on next round of presentation.
