# Fire Chief's Report

January: 0 incidents.

Station: upstairs needs to be cleaned out – any ideas what to do with items there?; David Dormaier took compressor to pawn shop and someone has placed deposit on it – could bring in \$500

## **Equipment**:

- Kodiak is at Fast & Easy; Ray checked some of items and found they were not repaired; Chief thinks we need to provide more of a specific task list
- Ambulance 122: have had 3 different fire departments call on it; one specifically interested and wants to check to ensure their equipment will fit; Chief will need to contact state if indeed sells
- Will need to submit grant request mid-March and if approved will need to have half of \$76,000 to receive grant
- Received two desktop computers and four monitors from dispatch center

#### Training:

- HazMat Ops training Chief and 2 others have taken written and will take practical in April
- Training every Wednesday have taken state chief's manual and added in-house items; training will be 60-80 hours; when completed individual will transition from probationary to volunteer responder

#### Mill Levy

# **EMS Billing Rates & Collection**

Board decided a few years ago that GUFD would adopt the County rate. Rates released yesterday with no change.

2015 – billed \$44,000; \$13,600 medicare did not pay; collected \$20,000. 63% adjusted collection rates.
