Fire Chief's Report

Call volume 6 calls in January

<u>Budget</u> – Recreated Budget to include PID funds of \$65,000 for staffing. Verified mill levy funds will be received in 2017; Linda & Chief are preparing exemption to audit paperwork

<u>Personnel</u> – New fee structure (attached); minimal cost to Department but reimbursable is at much higher rate

New hires will be recognized as volunteer until probationary period is satisfied, then paid

Ray tendered his resignation effective end of February

Station - few minor station repairs scheduled for January

Equipment - no fire equipment available at moment; Lands End has been notified to meet needs

Chairman's Report

County Commissioner Meeting – Fred will email to the Board a copy of letter he sent to County resulting in the award of PID Funds of \$65,000 specifically for personnel. Also addressed housing need, which is for the time being set aside as focus is on personnel. Will contact them in late February/March to prompt conversation on housing.

Each year Department will need to resubmit request, for 2017 around October, this time we will need to show difference the funds made

Motion by John that performance evaluations be conducted in February and finishing by March meeting Lisa Second All in favor / no oppose Motion carried

<u>Property insurance coverage</u>: Thought that equipment/vehicles are at risk of being under evaluated; Fred would like Chief to evaluate cost replacement and to get with Daniel for quote; would like to make decision at next meeting or get quote and approve via email.

Motion by Lisa to increase value of coverage on the 3 higher valued vehicles John Second All in favor / no oppose Motion carried

<u>Maintenance Chief report:</u> Engine 121 annual maintenance check; secondary pump down Board expressed their gratitude for Ray's efforts and service.

<u>Board Chairman position:</u> In unrelated discussion with Attorney, Attorney reminded Fred according to statute he cannot be Chairman past end of this year. Need to begin transitioning.
